<u>Meetings</u>

Susan P. and Lory C. will meet with the KCAJC Volunteer Programs Coordinator, and one or two other corrections officers, to discuss the problems we have had with frequent lockdowns. Since December 27, we have had 9 meetings scheduled. The inmates were "unavailable" (locked down) for 5 of those meetings. We have been provided with a phone number to call and inquire if programs have been cancelled before we drive out there, which helps, but I for one, would like to have more consistency with meetings. We are told that staff shortages are responsible for the frequent cancellations. There is probably nothing we can do to improve the situation, but I want to try and impress upon KCC the importance of carrying the AA message behind bars, and the commitment AA has made to this effort. I would like to appeal to them to make an earnest effort to get us in.

Training

In 2010 we had 22 AA volunteers bringing two meetings a week to alcoholics behind bars. Application forms for new volunteers are being circulated now. Training will be in May. If you are interested in participating in this program, please contact one of the current volunteers for more information. Training is only held once a year and you must be trained to participate.

Budget

We slightly overspent our 2010 budget of \$1000. We would like to propose an increase of \$500 for 2011. The Kane County Corrections program was also heavily funded from Pink Can collections this past year. This money enabled us to give a Big Books to every inmate who asked for one. This encourages people to study by themselves, or with each other, in between organized meetings. We also were able to make pamphlets and other literature written by inmates, for inmates, available to incarcerated alcoholics. The Grapevine Committee donated approximately \$125 in magazines to KCC detainees.
