The Area sent a contribution of \$9,000 to GSO as approved by the September Assembly.

Can Contributions

Pink Can Fund: has received a total of \$7,684.79 YTD in contributions. We have spent \$7,042.20.

Finance Committee Report Steve M, reported we met by conference call on October 11th, discussed PPM61 and PPM63 and whether they were complete or not. We thought that maybe they would be giving their reports at the Committee Meeting today and announce them that they were complete. Discussed the report on the proposed PPR for 2016. Very short discussion and was decided that the chairman of the finance committee should present the report. We also discussed the Present Register which showed us with an excess of \$1,179.87. Janet commented that some of the contributions received haven't made it on the Register yet. This was not discussed at or conference call. At the proposed PPR for 2016 meeting, our Corrections Chair requested \$600 to be part of the Illinois Sheriff's Association in October. Since there wasn't time before an Area meeting it was brought to us. The Operating Committee reviewed it and had passed it onto us. We did not have a Quorum at the time of 3 of us that were there said they were in favor of the motion. Our chairman, upon getting home, emailed the other two members of the finance committee asking them

to let him know their vote. They both supported the motion. We contacted our Area chair to let him know that the motion passed. . They are complete. PPR for 2016 and who will be presenting.

Operating Committee Report Chuck D, reported the Operations committee was asked by Dan L, NIA Corrections chair to review a request for funds to attend the Illinois Sheriffs' Association Conference as a vender. After some discussion we thought it best to pass the request on to the Finance committee.

Delegate Report – Cheryl V The 2014 Conference Reports have arrived! I admit freely that I looked at the pictures first. Yes, there are pictures in our report. I then took a moment to read the keynote address, delivered by J. Gary L., Northeast regional trustee. It was something that moved me at the Conference. I would encourage all to read it as it hits on several current and relevant topics. It was also interesting for me to read the report section on the Inventory questions from this year. In particular those questions that I participated and reported on. To see interspersed in the writing the various comments that came out of my group and how they were written so as to flow with all the other comments was humbling.

If this is your first look at a Conference Report, don't get so overwhelmed you put it down and never pick it up again. While there may be a few of us who read the Big Book cover to cover the first time we picked it up, probably most of us didn't. Read a little at a time. Look over the contents and pick something that sounds interesting. Was there a particular agenda item that interests you? Try looking in the Advisory Actions to see if anything came out of it.

It's rotation time for some of the Districts. If you are having elections in your Districts, please make sure you get updated information to Dawn for Fellowship New Vision (FNV) so that everyone is on the mailing list after the first of the year for the General Service Office (GSO) and the Area. I'd like to suggest that new DCMs and their Alternate's get Kelly, Robert & Marilyn your e-mail addresses as soon as they are elected to so I can get them on their lists right away. I'm guessing they would be happy to start including you now in communication also.

Speaking of rotation, I'm getting lots of e-mails from all the Areas that are rotating. What a pleasure to be able to reach out to newly elected Delegates and welcome them to this adventure. I was so amazed at the number of Delegates who reached out to me when I was elected. This year of course it is bittersweet. I got the wonderful chance of introducing Kelly & Robert to the Panel 64 & 65 Delegates. This communication went out as soon as I was home. I also updated the General Service Office (GSO) with all the election information on Monday morning as soon as I could scan it to send. This will allow our newly elected trusted servants to start getting communications.

I had an interesting opportunity to participate in "Donuts with the Delegate" hosted by Dean B. from Area 8, San Diego/Imperial California. Dean arranged for the meeting to have conference call capabilities, and then got three of us to call in to the meeting. This allowed the people attending to here from myself, Bruce D. from Alaska, and Mary Clare L. staff member from the General Service Office (GSO). While it was not his intention, all three of us served on the Literature Committee. It was great to hear the other two talk about things that had slipped my mind in the few short months since the Conference.

I initiated in a Delegate's Sharing request regarding workshops and expenses. This was in light of some discussion we have had here in NIA about the same. I specifically asked these questions:

1. When it comes to workshops, what does the Area pay for? (rent, coffee, literature, etc.)
2. If it's an all day workshop, does the Area cover the cost of lunch? Or is that paid for by attendees?
3. Does your Area distinguish between an Area sponsored workshop and one sponsored by a District? If so, how? In the event of this distinction, does the Area provide any funding?
4. And finally, if an Area trusted servant attends a District workshop, what expenses are reimbursed?

As is usually the case, most of the answers were quite diverse. I found it interesting that a number of the Areas do not hold workshops outside of their regular Area events. These Areas also have multiple day events, similar to our combined Spring Assembly and Conference. A number of the response included mention of potluck meals, the majority responded that attendees either pay for their meals in a manner like we do at our Area Assemblies and Committee Meetings, or they are completely on their own. Those that do not as the attendees pay specifically for the food pass the baskets, sometimes more than once until enough money has been collected to cover the costs.

Upcoming Events

The NIA Big Book Conference is on the horizon. Scheduled for next Saturday, October 24th in Palatine, it will be hosted by District 21. One of the things that many of us are guilty of is waiting to register and not planning in advance. This makes it very stressful on the planning committees. They cannot guess how many people will attend. While “paying at the door” may seem easier for you, please consider that this committee needs to place orders for food based on what they guess will just show up. If you arrive late, you may not be able to buy lunch. And if we don’t get enough people attending and buying lunch, we may not be fully self-supporting.

The East Central Regional Forum will be held November 13-14 in Milwaukee. This is your chance to meet members of the General Service Office staff and General Service Board. It’s also your opportunity to ask questions. This is one place where it doesn’t matter if you are at the top of our inverted service triangle or down closer to the bottom where I currently sit. Any AA member can go to the microphone and say what they’re thinking. Online registration for all of the 2015 Regional Forums is available at www.aa.org where the Regional Forum Flyers and Registration Forms can also be viewed and printed.

Planning is underway for the 2016 Panel 66 General Service Conference. They are looking for suggestions to list as potential ideas for the theme, presentation topics, and sharing sessions. I will forward out this memo to the Area Committee. These are needed by December 15th. I’d like to suggest that perhaps any District interested in participating add this to their agenda and give their GSRs the chance to participate in a small way with the conference. It appears that you can send your suggests in yourself, although if you wish to have me forward them I will be happy to.

We will be hosting the Illinois State Conference and East Central Regional Conference in August. I’m sure Carl will be having a report. Please consider volunteering to help plan.

Motion: Request for revision to the Bridging the Gap pamphlet

Presented by Carol H,

Rich H seconds the motion

Questions/Discussion:

Rich H, our delegate will write a letter, correct? Cheryl V, I have asked Carol to write the letter, I will simply forward and sign my name.

Intent is for letter to be submitted on behalf of NIA if approved.

Cheryl, the reason I am asking Carol to write is that I am in opposition to this. Cheryl read last year's report of the General Service Conference regarding this topic. As a member of the literature committee, I do not think it appropriate it goes to the literature committee. They have 4 pamphlets in complete review on the agenda and 2 additional advisory actions. Feel this would lose emphasis in this committee. I suggest BTG go out and determine what specifically is needed for corrections. It is easier to move forward when you come forth with specific recommendations. Better service by BTG committee to bring a more precise motion next year.

Carol, we were advised at the BTG Workshop that by including both Corrections and Treatment committees, we could provide additional reasons for looking at the pamphlet. I can put specific recommendations in the letter.

Gary, DCM D73, supportive of BTG as I am a beneficiary of it. Worked in county jail for 22 years. Cheryl did voice her opinion, but please go back to GSRs. In my district there is a problem of merging Treatment Facilities and Corrections into BTG. How would needs be met in your district? Need to approach carefully.

Rich H, BTG chair, remember, our job is to represent what we think is in the best interest of AA. We are asking for help to bring this together since there is not a BTG desk at GSO. We don't get to pick who we help.

Jeff G, still operate by inverted triangle where meetings and groups and members are at the top of the triangle. We should let the agenda make us decide why we want to do this. I agree I don't get to choose who I get picked to help. Need a broader process at conference level.

Terry W, we don't have what's going to be in the letter. Before you put NIA on the letter, we need to know what it's going to say. I would be hesitant to approve without knowing.

Dan L, letter will be presented at assembly. We put specifics in the motion. Not trying to rewrite, trying to make it better.

Larry S, Panel 56 Past Delegate, I agree with Rich; I don't care how busy literature committee is or what they said last year. Remember groups can ask the conference to make a change.

John C, Panel 58, Past Delegate, some good things being said. I am a true believer in informed group conscience. DCMs unless they wrote down verbatim, don't have what they need for an informed group conscience. Groups are going to be making this decision and we need to do this correctly.

Robert S, Carol will send revised motion and will go out to all of NIA with preliminary agenda in next 2 weeks

Carmela, Alt Registrar, it is exciting to be a part of this process. Question is do we want to actively participate in the spirit of this motion to approach, in a fresh light, BTG. Motions evolve and don't happen quickly. Caution that we don't spend time trying to get it perfect but put something forward with support of groups in NIA. Getting group feedback and discussing is better than whether it gets added to agenda.

Ray M, this body, as an assembly, has the responsibility to present a motion they agree upon. Responsibility of delegate to send letter. Support of motion is what we are looking for.

Barbara H, DCM D21, hearing that this is something to take to district as a topic of active discussion and talk to groups for input. Deadline is Dec 15th and the next assembly Dec 12th; that suggests input must arrive before the assembly.

How should we add opinions prior to whom should we direct our thoughts? Carol, I or another member of BTG would be happy to visit your district meeting to discuss.

Phil, Alt DCM D62, I'm confused. Difference between TF and Corrections. If I can't go into prison; it's hard to bridge the gap. If they can't tell someone where a meetings at, there's something wrong.

Rob M, Alt AS Chair, I've heard this body talk about BTG for over a year. Partially how we do 12th step work now. Although I was confused why we need BTG, reality is we need this. We're rehashing what needs to be done for a pamphlet that seems woefully inadequate. This needs to be put to fellowship for input.

Matt, DCM D64, is December 12th enough time to get information to meet the December 15th deadline? Cheryl, timing will happen in time. Will be sent to three committee chairs and the conference coordinator. Trustees committee will determine if the motion moves forward. If moves forward, staff person will gather background information.

Joe L, DCM D61, we discussed BTG at our district meeting and I struggle in defining what it really is. Maybe we need to look beyond pamphlet to the guidelines. It would be helpful for me and my district members.

Carol H, not first time this was presented. I know there are a lot of questions, so I would be happy to visit your district. BTG workshop weekend celebrated their 25th year this year. Don't let your lack of knowledge prevent you from moving forward.

Jeff G, when you started you asked for a second because Carol had presented on her own. What has brought Carol to do this if she hadn't gone through BTG committee? Carol, I presented to Robert and decided at Fall Assembly not to present. I was asked to do this by our BTG coordinator.

Robert, we need to wind discussion down

Larry S, I don't hear anyone saying much about a motion - we are talking about procedure. Who cares? BTG is a relatively simple process. The existing pamphlet doesn't say anything about corrections. At very least it should acknowledge there is corrections. This is not difficult. Let people who do the work do the work.

Eva DCM D91, we don't have any TF and our prisoners are from up here. We have lots of alcoholics in nursing homes. Nice to be included.

Motion by Corrections Committee to send literature to SIA 21

Question/Discussion: Chuck D, DCM D10, number of books are different, why is that? Dan L, noted difference between 2014 and 2015

Dawn B, why do we take care of their jails? Dan L SIA doesn't have same monetary abilities as NIA. NIA is blessed with more funding and our membership larger. Matter of supporting our sister area and their financial needs.

Cheryl V, would it be better for Dave at SIA to receive quarterly? Dan L, he was hoping to have by winter assembly.

Rob M, how much of this are they funding or is this all NIA paying for SIA institutions? Dan L, I cannot speak to that. I was asked to provide one case per facility. Asking for help in their shortfall.

Chris V, wonder if possible to reach out to PI person at GSO? Dan L, with quantity we're ordering, getting a break of \$800 and free shipping

John C, treasurer reported today and what committee is asking for. We don't have the money right now. Are we going to have money by Dec 14th? Judd W, if direction of assembly is to pay for this in December, quite likely it will come out of reserve.

Matt, why can't we pull from Pink Can? Dan L, NIA collects pink can contributions for our area and not SIA.

Robert, might consider to have an answer to specific answer to what SIA is doing.

Old Business:

2015 Big Book Conference, Barbara, reported 147 pre-registered. I can take registrations today. Flyers are on the table that include a barcode to online registration. Final planning meeting tomorrow. Online registration closes Tuesday.

2016 Spring Conference, Terry reported, should be ready for online registration by November.

2016 State Conference, Carl T reported, our last planning meeting was held Oct 11th. Attendance was fair, we still have a couple Chair and several alternate positions open. Our program committee has been busy contacting and lining up speakers. All but the GSO and AI-Anon Speaker have been confirmed. We hope to have a commitment for the GSO speaker from our new General Manager next week. Area AI-Anon Chair has provided a Convention Liaison as well as a contact for AI-Anon participation in this conference. I will be working in conjunction with the program chair to reach out regarding program, speaker, and other participation in the conference. Budget is being finalized now so conference fees can be set. Final flier is in Design with hope of having it ready for the Regional forum in November. We are planning to have our November 8th meeting at Pheasant Run in St. Charles. This will include a walk-through of the facility to help

each of the current chairs in their planning. I am also communicating through our current delegate with the Conference Policy Committee regarding the need for a possible walk through of the facility according to the guidelines.

National AA Technology Workshop, John C reported, John C, was there any shared expense in other areas such as online contributions; John, there was a breakout session – it is an increasing difficult problem. More difficult to manage. Will continue to be discussed. Need for security on our website is lower than sites that include online contributions. Chair Robert S reported, since our Fall Assembly, I have attended the Finance Committee meeting that took place in preparation of presenting the 2016 Proposed Primary Purpose Register.

I have secured a replacement member for the Electronic Equipment Committee to take Ed R's place until the end of the year – at least. Please thank Kevin B for agreeing to do this. He has been elected to be District 22's incoming DCM but hopefully he will be able to do both jobs.

I have begun putting together all my files to be turned over to Marilyn (our incoming Area Chair) and preparing documents to aid in the transition. I remember, from my first few months, the enormous task of filling the appointed positions. Please don't run when she comes over and asks to talk to you.

Since one of my first responsibilities, in my new position, will be to send out the agenda and background information to all the DCM's for the 2016 General Service Conference, I am asking all rotating DCM's to please let Dawn know as soon as possible of the DCM Elect's contact information so that we have that updated prior to the end of the year. I will also be coming around today and at the Winter Assembly asking for that information myself.

The Report & Charter Committee has been working, diligently, on revising the documents that make up the Area Guidelines. I was hoping that this would be completed by now but it is truly a daunting task. The goal was to be able to have one cohesive document that could truly be called the NIA Service Manual and it not be just a collection of the various individual documents that are our guidelines. I know that they have made a lot of progress and are close to having the bulk of the work done. I hope that this will continue with the next committee until complete.

We will be reviewing the proposed 2016 Primary Purpose Register. I caution you to not get into the "weeds" with the dollar amounts but to remember that these amounts are estimates for the purpose of calculating the Prudent Reserve, which is based on a percentage of the total of those amounts. The amounts do not mean that we have to spend that much or not go over the amount – they are just estimates based on past experience and current trends. Instead, let's focus on the activities and make sure that we have everything that we are responsible for doing and not anything that we think is not appropriate.

We have two motions on the agenda. The first is from a DCM (Carol H) about having our Delegate write a letter to the related committees at the General Service Office regarding the Bridging the Gap flyer. The second is from our Corrections Committee regarding sending literature to SIA Corrections for use in prison in southern Illinois. I have attached background material for both in the form of Appendixes. The background information includes previous requests for the same.

other areas. I did share with him our 3 meetings within our area. He wants to travel to a meeting in Rockford. He is involved to help the hearing impaired community. They have AA hearing impaired meeting on an OOVVOO on webcam on every Sunday and Thursday night at 7PM CST. Also, Deaf Recovery Community (DRC) on Facebook has over 200 members. Sounds of Sobriety (SOS) online email group was formed to help us who have hearing loss (deaf, deafened, or hard of hearing) to find a place to recover from alcoholism. For many, face to face AA meetings no longer work. All members of AA or those who think they may have a problem with alcohol are welcome. SOS online group-subscribe@yahoo.com

Although they only have a couple of outpatient facilities, they have quite a few correctional facilities, including Dixon Correctional Facility and the Thompson Federal Prison. From the Treatment side, I spoke about the importance of the BTG program, at the treatment center that I go to in Rock Island has a lot of people from their district. On several occasions those people are released back to D73, have asked for BTG services and no one to give them to.

Web Administrator, John reported, in this report I've only included some highlights of the National AA Technology Workshop I attended in the first weekend of October and some early results of that experience. We'll see those results continue to develop and evolve for some time to come. I believe they will have a profound effect on at least the web-related technology in Area 20 and perhaps more than that. I will give an expanded report at the next assembly so that the GSRs can make their groups aware of the great value of that workshop. Please note that Jeff S. from district 90, Jeane M. from district 41, Magic M. from district 43 attended as did one other Area 20 webmaster whose name I did not record but from whom I await email contact. My apologies to any that I missed.

An interesting trend came to light early in the workshop: in response to rapidly advancing technology many districts, areas and intergroups have created technology service committees under which they have placed their website operations.

Much of the workshop value came from incredible networking and brainstorming opportunities. As a direct result of the conference the following items emerged.

- We formed a website administration committee consisting of me, Ben M. (alternate website administrator and district 61 webmaster), Jeff S. (district 90 webmaster) and Earl N. (district 10 webmaster). Our goal is to form an area-wide webmaster support group so that we can collaborate effectively.
- We identified the current functions of the present Area 20 website. We decided to convert the website format to WordPress, which among other things will make it responsive, i.e. automatically adaptable to smartphones, tablets and computer screens alike. Earl's terrific work on the District 10 site will be part of the new design approach. The WordPress conversion will also make our site more sustainable, i.e. more easily passed along to future trusted servants with less than professional skills.
- Jeff S. is developing a "Keep it Simple" website package available for easy adoption by anyone in AA, and Alternate Ben M's district 61 site will be the first test bed.
- Area 20 may be one of the first to participate in a 12 Step Meeting Finder project destined to be available on any CMS-based website as well as a free standing smartphone app.

In a deeply moving presentation a small group of deaf AAs illustrated the need for making ASL interpretation more widely available by turning the audience into recipients of the translation while they told parts of their stories. A leader of that group told of being accommodated very well by our own Urbano after getting no assistance from a nearby area.

Thank you for the wonderful opportunity to attend the NAATW. Look for more detail at the next assembly, when I'll update you on the highlights mentioned here and will have a comprehensive written report.

6. Our Treatment chairs Bill C and Julie H report that the Bridge to Shore meeting held at noon on Wednesdays at St. Marks' continues to be active. It's a great place for people in treatment programs, people recently released from treatment programs, people who have had recent relapses, and newcomers.
