## **POINT OF ORDER**

Ray M. point of order on Candidates declaring what positions they will be running for. Believes Area Chair does not have authority to change 3 Legacy or procedure. Asks that you withdraw it. Chair declines. Ray makes motion to vote to NOT do this, Cheryl 2nds it. Ray says his point is that chair lacks the authority to do this today. It makes a fundamental change to the 3<sup>rd</sup> legacy and introduces the opportunity for politicking. Questions; none. Discussion: Rich H, I like the idea, part of the reason we have committee mtgs is to have DCMS inform districts. This would be the opportunity for DCMs to bring this info back. Our GSRs don't always know who their voting for, but discussion by groups ahead of time will help. It's a good idea to know who may be standing. People can also change their mind about running or not. This gives groups/GSRs the opportunity to discuss who's running ahead of time. Bill W.; Feel like I'm being put on the spot to step up today, we need to have more discussion at the Assembly level to put this into practice or not. Cheryl V; This topic came up at Service Structure, this change to our guidelines should be decided by Assembly, not one person or the Area Committee. Jeff G; I agree that this is a good thing, better to know who's running. Discussing it right now is a good idea. Tom B; Question, if we do this that doesn't stop anyone from being nominated or standing at assembly?. In the ancient past we did have nominating committees to go around and ask who would run. It avoided having people who could not do the job standing for it. We need to see that we have the candidates to fill the most important positions. I don't see any harm in this, and I don't think it's beyond the Chair's authority. We need responsible people. Terry; The only thing i want to bring out is that I know in many groups and Districts they do noms a whole meeting before elections take place. Going from my own experience I don't see the harm. Chris D; I agree with what Tom said, this is a room full of Area people, the people who lead their districts and Area in service. It's a good idea if this body knows who's willing to stand. A discussion and knowing who's interested wouldn't be harmful. Larry S; Topic is not whether it's a good idea, it's does the Chair have this authority? How many DCMS told their districts? Answer is one. If you're not here today you can't declare your intention. Can we make this change without the permission of the assembly? There is a fear among GSRS that committee will run area without Assembly, Robert S; do guidelines address this? Ray, no, they don't. The elections are a matter of the Assembly, the third legacy. Is the chair and the Area Committee the ones to make this change? Rich H; 6 years ago Terry ran elections the way our service manual said we do it, and no ones done it that way since. 4 years ago I stood alone for Alternate Delegate. I think if we see there is a lack of people to stand that we then have the opportunity to encourage others to do it. Show me where it says we can't do this. Larry; I have an issue with "show me we can't". Nowhere in the guidelines does it say I cant put a link to a Conference on Facebook, but when it happened many objected. Just

bc it doesn't say we can doesn't mean we should. Michelle H; I understand what Ray is saying, but sometimes it's time to try something new. I've been to elections 3 times, and there have been times no one has been elected. This would give people the chance to talk about what positions need to be filled.

Fellowship New Vision database

Fellowship New Vision database (FNV) was developed by the General Service Office and released for use by the areas in May, 2007. FNV is a web based tool and because of that, updates are immediate. FNV also provides each area, via their Area Registrar, access to update certain area information directly into the database. Because FNV is an online-real time database, what is entered by either the areas or the GSO Records department is available for immediate use.

Four times a year the Alternate Registrar will be sending to the DMC and the District Secretary a document of all of the groups in their district. The last column is where updates can be entered. GSRs can update group information by working with their DCM or district secretary or by completing a group information change form which they can find online at

http://www.aa-nia.org/forms.html.

Group information includes group name, group number, area, district, history dates, meeting locations and times, and complete group contact information. District information, on the other hand, includes district service positions and contact information for those elected to those positions and Area information is similar to district information but at the area-level.

This information is the key to communication throughout the A.A. general service structure. GSO uses group information to send information kits to new GSRs, copies of Box 459, the GSO quarterly newsletter, and GSO quarterly reports. Similarly, the area uses the information to send to the group Concepts, the NIA newsletter, and area assembly meeting minutes. This information is also used by GSO to send information kits to District and area-level committee chairs to help orient them to their service positions and by area service committee chairs to communicate with their district counterparts.

Since we will be sending minutes via e-mail, please check with me or your DCM to be sure that your e-mail is correct in FNV. In FNV the Registrar can search for groups or individuals and do instant updates.

It is no longer necessary to send group information updates to both NIA and GSO. All information update requests can be sent to the area registrar at registrar@aa-nia.org.

1. 2013 State Conference (D22&23) Larry S, co-chair reporting

The theme for the 2013 State Conference, hosted by District 22 and 23, is Our Solution in Action. The conference will be held August 23 - 25, 2013 at the Hyatt Regency Woodfield in Schaumburg (1800 W. Golf Rd.) which is across from Woodfield MallAs of yesterday there are 235 registered and 192 have purchase banquets. A quick review of the registration list reveals that only twelve area committee members have registered for the conference. The room rate is \$89 per night. The room block is being held open until further notice. The phonenumber for room registration is 1-888-421-1442. Refer to the 2013 Illinois State AA Conference. As of Friday, August 9th there were a total of 149 rooms reserved. At 150 rooms our liability to the hotel is \$1000. At 170 it's \$500 and at 190 it's zero. The event is hosted by Districts 10, 11 and 12. The Conference theme is: "Living in 10, 11 and 12". The event will take place March 28, 29 and 30, 2014, at the Holiday Inn Gurnee Convention Center: 6161 W. Grand Ave., Gurnee, IL, 60031. Registration starts at 4:00 P.M. [The Convention Center is located at the southwest corner of I94 (TriState Toll way) and Grand Ave. (Great America exit).

PLEASE NOTE: The September 8<sup>th</sup> meeting will be held at 2:00 P.M. at the Holiday Inn Gurnee for the committee's first walk through tour of the facility.

The 2014 Spring Assembly Conference budget was based on the following:

600 Registrations @ \$20.00 each [2013 Spring Conference had 654 registrations - 50% walk-in)

300 Banquets @ \$35.00 each [2013 Spring Conference sold 328 banquet dinners]

250 Hotel "room nights" at \$89.00/night (Double or King beds) [2013 Spring Conference sold 236 room nights]

Final Banquet numbers are due to the hotel on March 24, 2014. The 2014 Food and Beverage commitment is: \$8,500.00. NOTE: Box lunch and ice cream social proceeds will apply towards the \$8500.00.

All Committee Chair positions have been filled. A few Alternate/Co-Chair (4) positions are open. The requisite A.A. and Al-Anon speaker commitments have been secured; their names and cities appear on the flyer. As is customary, the Sunday morning A.A. speaker will be from the General Service Office. Al-Anon does plan to have an Alateen speaker; the flyer will list the Alateen speaker as "TBD" [to be determined]. Banquet meal choices are: Combination Beef/Chicken or Vegetarian. Box Lunches consist of sandwich, chips, whole fruit, and beverage. Choices are: Ham, Turkey, Roast Beef, or Vegetarian Wrap.

Flyers will be available and will be distributed to DCMs at the Area 20 Summer Committee Meeting. The flyer is "bilingual", with English on one side and Spanish on the other. Eight thousand flyers have been printed. A registration table will be at the State Conference (August 23rd-25<sup>th</sup>) in Schaumburg.

A registration table is planned to be set up at Area 20 events, e.g.: Assemblies, Committee Meetings, etc. Chair, Bob Pierce and Alternate Chair, Bill Woolridge plan to visit all (25) Area 20 District meetings in order to promote this event, pass out flyers, explain what help will be needed from individual Districts, and answer questions. Mailing of the flyers to surrounding Alano Clubs, etc. is planned. The DCM from District 20 has asked for flyers to distribute to 83 Spanish speaking meetings in Illinois. The flyer will be posted on the 2014 Spring Assembly Conference website. Electronic distribution of the flyer is planned. Individual Districts will be solicited for help with: Alcathons, Panels, Greeting, Hospitality Room, Registration, Public Information, etc. The committee is hoping to be "proactive" in securing registrations throughout the upcoming 8 months.

### **District Actions**

A successful 6<sup>th</sup> and 7<sup>th</sup> Step Workshop was held in mid-March with 30+ people attending to participate and learn more about these important, but sometimes forgotten, Steps. Another workshop concerning sponsor/sponsee relationships is going to be held this September at Faith Evangelical UMC in Elmhurst.

The District 41 website was updated. This includes district meeting information being updated regularly, helpful information being added for Answering Service home volunteers and new, updated descriptions for our service positions.

We had an incident at the Lombard branch of the Du Page Crisis Intervention Center in July. During an AA meeting being held there the patients were erroneously told by an AA member that bipolar dx didn't exist, that the 12 Steps could be used in such situations.

Our participation with at Elmhurst Hospital's Intensive Outpatient Program has been expanded to 3 times a month (we provide two speakers and follow up with a question/answer period).

Haymarket Symposium, held 6/10-12/2013, seems to have gone well. I believe that we had 8/9 volunteers that participated. The volunteers talked with treatment-related professionals and passed out literature. We'll never know the impact we had on these people as they came from all around Chicago, Illinois and I'd assume some from out of state.

One of the services District 41 performs, is distribution of A.A. pamphlets through our local libraries. Here is a breakdown of our library pamphlet distribution since 7/12/12:

That's over 1200 known pamphlets distributed in the last year, with a vast majority going to our local libraries. The Lombard library actually e-mails requests for pamphlets to us now when their supply starts running low. Pamphlets are given to one of DuPage County's DUI evaluators on a regular basis, one of the Du Page County clinics and to Kane County's Victim Impact Panel. The Bensenville and Addison libraries were added to our distribution program in the last few months. Distribution numbers for each library were 100 pamphlets in July; both in English and Spanish. Last month we had someone volunteer to support the Villa Park library on a regular basis.

The District Answering Service actually has an office to be manned by volunteers; the problem has been manning that office with volunteers. We have been experiencing to many vacant time slots or 'no shows'. It was decided that we should look into an outside service. At our last meeting a motion to look further into "Answer Call" system was approved.

- 5. Your CPC Committee has been invited to participate in the "Open Hand of AA: Tools for Reaching the Still Suffering Alcoholic" session at the upcoming Illinois State Conference being held at the Hyatt Regency Schaumburg, August 23-25, 2013. This session will be held at 9:00 AM on Saturday in the Mahogany 1 Ballroom. - 1. Bids for the 2014 Big Book Conference; To Fall Assembly
- 2. Motion by the Finance Committee to amend the guidelines for the prudent reserve, Presented by Mike M. AMENDMENT; "IT IS MOVED THAT UNDER THE GUIDELINES FOR THE PRUDENT RESERVE ON PAGE 48 OF THE HANDBOOK, IT BE AMENDED TO READ 'THE PERCENTAGE SHALL BE 25%".

Questions; Cheryl V; In the summer assembly it was recorded that prudent reserve was raised to 18k, and original motion was that 2013 we would have 30% of PPB. So we are already at 30%, is it your suggestion to lower it? Mike; Yes, lower back to 25%. Cheryl: FRIENDLY AMENDMENT NOT GOING TO INCREASE FOR 2013. Mike M; YES. Terry; Actual Motion should strike "and increase to 30% in 2013". Mike; Yes, it's already there. MOTION WOULD BE TO STRIKE PAGE 48 OF HANDBOOK STRIKE PARAGRAPH AT TOP THAT SAYS THIS PERCENTAGE WILL BE INCREASED TO 30% IN 2013. Erik L; let's not get hung up on semantics, change wording in handbook to 25% if you strike out last words of last sentence. Ray M; Speak to the analysis please. Mike M; General increase in contributions and low rate of expenses are the reason, and it's reflected by the Treasurers report today.

Discussion; Larry; I would be opposed to this. The motion to increase came before last year, there were no unexpected shortfalls on horizon. There are never unexpected shortfalls. We don't know what's going to happen next year. We already have 30% in prudent reserve, why would we want to back it off? Bad things CAN happen. We cannot always guarantee financial security, why give that away and lessen prudent reserve. Mike F; Sentiment that I have received that we are sitting on too much money. Cheryl; I would be opposed to this motion for similar reasons as Larry. We have been down to 800, had the conference costs hit us when we had only that, it would have had to come out of prudent reserve. Erik L; We looked at previous years, not a one year anomaly. We felt 3 months was enough. Carmela; The rationale for this is certainly not provided within the motion. Should definitely be clearer before vote at assembly. Lee; In my district we have operated below prudent reserve, it's confusing to me, since God will provide. In my district prudent reserve is usable money. We don't NOT touch it. Just to leave it sit there to never be touched strikes me as unnecessary to discuss. Michelle; we have 32k commitments in the next month with 17k in the bank. It was raised to 30 percent for a good reason, and that might even be too low. Rich; I'm neither for or against. We seem to have a fear of touching money that's set aside. Are we accumulating funds for no purpose? NEW MOTION SHALL READ; (IT'S ON MY PAPER)

3. Motion by the Finance Committee to add to the procedures for presenting motions; Mike M presented.

Questions; No. Discussion; Cheryl V; Opposed. In asking to do this it's not in the spirit of the concepts. Our service committee chair should not haveto go before anyone else. If it's coming out of committee, they should not have their

work reviewed by another committee. Are we now demanding that our finance committee review? Wording is already in place for review when approved.

4. Motion by the Finance Committee to amend the finance committee guidelines; Presented by Mike M.

Questions; Michelle H; If you are doing this as a finance committee separately then what are we taking back to our districts? Mike; in past years, there have only been a handful there, the thinking would be we would get more people if we did it this way. They will have plenty of time to discuss with districts. Joe; In light of previous motion, it doesn't make sense. Mike F; the previous motion was talking about PPMs, this motion is about PPBs. Cheryl; Is it your intention that finance committee is a line item on the agenda? Mike F; it would be at end of committee meeting. Cheryl; You're asking all to do committee and then stay later to conduct further business. Mike F; we wont be here that late. It will be the same day and actually be a time saver. Ernest; Why was 3 weeks prior put in there? Mike; past history was that we discussed and reported to committee. So why go line by line and then 3 weeks later go line by line when no one comes to the 3 weeks prior finance meeting? Trying to SAVE time here. Discussion; Chris D; Former Finance Committee Chair, from experience I didn't know what our responsibilities were, keeping in mind that this is summer committee, then fall assembly, then fall committee, I was told prior to fall committee we needed a cohesive budget at Winter Assembly. I could not have been prepared without that 3 weeks prior meeting to get things ready. Robert S; Motion 3 and 4 are contradictory. The guidelines also say that you will work to resolve issue one week prior to Fall Committee Meeting. I think motion needs to be rethought. Carmela; Similar sentiment, not in favor of it. We cant make good decisions based on this motion. Ray; page 41 of most recent handbook "scheduled agenda items prepare and approve proposed calendar and budget at fall committee mtg". How can that happen?Erikk L; Ive never seen a more convoluted budget process. Simple intent was to let finance take a look at a new motion, we can weigh in for a more informed assembly vote. Terry; this is a holdover back from the old budgeting process when every chair had to argue for their share. PP Financing was supposed to eliminate this. We should be able to review PPMs as they come up to simply recommend or not to the Assembly. Larry; Why does finance committee get input into the motions of others? Sounds like we are investing an awful lot of authority in Finance Committee. These things need to be clear. Karen M; Friendly amendment . MOTION NOW READS; IT IS MOVED THAT UNDER THE "FINANCE COMMITTEE GUIDELINES" ON PAGE 67 OF THE SERVICE HANDBOOK, IT BE STRICKEN THAT THE FINANCE COMMITTEE NEEDS TO MEET 3 WEEKS PRIOR TO THE FALL COMMITTEE MEETING AND BE REPLACED WITH "THAT THE ANNUAL PPB REQUESTS BE SUBMITTED TO THE FINANCE COMMITTEE AT LEAST 3 WEEKS PRIOR TO THE FALL COMMITTEE MEETING SO THAT THEY MAY BE REVIEWED AND DISCUSSED BY THE FINANCE COMMITTEE PRIOR TO THE FALL COMMITTEE MEETING" Larry; I was involved at the beginning of Primary Purpose Finance. I'm not sure everyone understands it. Maybe some changes are needed, but maybe we need to get some Finance people together to discuss it.

### Background:

### 2. Motion by the Finance Committee to amend the guidelines for the prudent reserve

It is moved that under the guidelines for the prudent reserve on page 48 of the handbook, it be amended; TO STRIKE" INCREASE IN 2013. NO INCREASE IN 2013. RETURN PRUDENT RESERVE TO 25%"

#### **Backround**

It was thought at one time this was needed to cover shortfalls due to unexpected expenses. However it does not seem this is necessary now.

### 3. Motion by the Finance Committee to add to the procedures for presenting motions

It is moved that in the "Procedures for presenting motions to the area Assembly" portion of the service handbook on page 40, it be added that "All motions that affect the PPR are to be reviewed by the finance Committee prior to the Committee meeting and subsequent Assembly.

#### Rationale

It seems prudent that The Finance Committee check procedures, dates, guidelines, and specifics of the motion to make sure it is planned on being inserted into the PPR at the proper point to guarantee availability of funds and provide the Assembly with a more informed decision.

# 4. Motion by the Finance Committee to amend the finance committee guidelines

It is moved that under "Finance committee guidelines" on page 67 of the service handbook, it be stricken that the Finance needs to meet 3 weeks prior to the Fall Committee meeting.

### Rationale

The Finance committee can accomplish what it needs to get done with a meeting at the Fall Committee meeting. The current wording of the service handbook "Schedule and conduct an annual PPR meeting at least three weeks prior to the Fall Area Committee Meeting." We would like the wording to be "Schedule and conduct an annual PPR meeting at the Fall Area Committee Meeting".
