The East Central Region has voted to host a hospitality room at the International AA Convention to be held in Atlanta over the July 4th weekend. The hotel has quoted a rate of \$60 per gallon for coffee, and the committee felt that the price was rather high, and since it will be July and hot that perhaps bottled water will be a better choice. The hotel will charge a "corking fee" of \$0.75 per bottle. Work is still being done to find a place to buy the bottled water with some type of label. Motion:

Explanation:

CHICYPAA will include the letter in their bid package which will be presented at the conference on September 3-6, 2015 in Miami, FL. NIA's letter of support is the fulfillment of an old bidding requirement the committee would assure the conference would not conflict with any locally hosted AA events.

Background:

ICYPAA (International Conference of Young People in Alcoholics Anonymous) is a self-supported traveling conference which meets in a different city throughout the United States and Canada. The first conference was held on August 17-19, 1958 in Niagara Falls, Canada where Bill Wilson was in attendance and had contributed a letter of support endorsing the event. He cited the enthusiasm it brought to the overall movement. The second conference was hosted at the Palmer House in Chicago, IL. Young People's conferences have acted as a gateway to AA for younger (young at heart members) to general service. ISCYPAA is the largest of the over 60 young people's conferences which are held around the world.

ICYPAA conferences receive around 70% of its attendance from a 300 mile radius of the host location which includes Northern Illinois 20.

Locally, the Young People's scene has become really popular. The 2015 ISCYPAA (Illinois State Conference of Young People) was hosted in Northern Illinois 20 at the Westin in Lombard where 7 groups from around state placed a bid to host the next conference. In April 2014, the Eastern Area Conference of Young People EACYPAA was hosted in Chicago where over 1500 young people in attendance many from Northern Illinois 20.
