2018 Spring Assembly Cover Letter

## Welcome to the 2018 Spring Assembly!!

First off, thanks to District 22 for hosting today's assembly. A lot of work goes into making sure these Area meetings go off without a hitch and we all appreciate your service.

Attached to this cover letter is the agenda for the 2018 Spring Assembly.

Looking through the agenda there are a couple items to point out. First, just as we did at the Winter Committee meeting, you'll notice that in place of reading of the entire 12 Concepts I have instead apportioned time for the reading and explanation of just a single Concept, this time Concept II.

Next on the agenda we will hear bids for the 2019 Spring Assembly Conference (this conference) as well as the 2019 Illinois State Conference. Then you'll notice a rather rare item, which is a floor motion from the Conference Advisory committee. That committee has submitted a motion to me (in writing) per the guidelines, in sufficient time that I am able to include it as an item on the agenda. The exact floor motion reads as follows:

**Motion** - On behalf of the Area Conference Advisory Committee it is moved that the 2019 Spring Assembly <u>Conference</u> be cancelled. The 2019 Spring <u>Assembly</u> will convene as a stand-alone event at a location to be finalized when the 2019 calendar is approved later this year.

**Background**- This motion is being prepared and submitted to the Area Chair as a floor motion to be presented in the unfortunate event that no bids for the 2019 Spring Assembly Conference are accepted at the 2018 Spring Assembly. The committee feels that without a binding bid at today's assembly there will be insufficient time for a future committee to properly plan for and execute a Spring Assembly Conference in 2019, as this would mean that committee would have less than 12 months to prepare. This motion only affects the **2019 Spring Assembly Conference**.
