## Panel 68 General Service Conference Log

Sunday, April 22, 2018 opening session began at 10:30 AM with a welcome from Michelle Grinberg, Class A Chair of the General Service Board. Greg T, Manager of the General Service Office presided over the roll call of Conference participants.
