# Northern Illinois Area (NIA) 20 Finance Committee Motion NIA Winter Committee Meeting January 11, 2020

Motion from the 2019 Finance Committee:

The Finance Committee moves that the NIA Primary Purpose Register (PPR), Activity number "B02 - General Service Conference Contribution", be revised to reflect the Area's intention to fully-fund the cost of our Delegate's participation in the General Service Conference (GSC) ongoing from 2020 forward.

**Background:** For many years NIA has paid the entire cost of participation at the General Service Conference (GSC) as determined by the General Service Board (GSB). However, it has been an unwieldly two-step process because the GSB does not advise participants of the expected costs until early in the calendar year of the GSC. Past practice has been to send an amount equal to that years cost to the GSB at the end of each calendar year as a "down payment" for the following year. After the actual costs are announced, a supplemental motion has been made to forward the balance, if there is a difference from the amount paid. Revising the PPR would authorize the Treasurer to pay the amount suggested by the GSB and eliminate the need for a second motion. For planning and budgeting purposes the Finance Committee could use a rounded amount approximating the current year's actual expenditure in the next year's proposed Primary Purpose Registry.
