Total operating revenue is projected to be \$16,714,400 and total operating expense is budgeted at \$18,091,497, resulting in a deficit of \$1,377,097.

Reserve Fund-

As of June 30, the reserve fund balance net of Grapevine subscription liability is \$12,892,600, which represents 7.57 months of 2022 G.S.O., Grapevine, and La Viña reforecast expenses.

Total revenue for the year is estimated to be \$1,534,521 compared with \$1,696,310 in 2021. Total expenses which include editorial, circulation, and general and management costs are budgeted at \$1,796,739 compared with \$1,808,929 last year. After adding interest earned there is a budgeted deficit of \$262,218 compared with a deficit of \$112,618 the previous year.

La Viña -

Total expense is estimated to be \$561,456, compared with \$429,809 the previous year. This creates a budgeted bottom-line deficit of \$557,723, compared with a deficit of \$388,646 in 2021. The shortfall for the La Viña service activity will be funded by a transfer from the General Fund of the GSB.

LITERATURE

The committee reviewed progress reports on several ongoing projects including the pamphlet "A.A. for the Black and African-American Alcoholic," the development of a Fourth Edition of the book *Alcoholicos Anónimos*, and the development of a Fifth Edition of the book *Alcoholics Anonymous*.

Remember the deadline to submit stories for the 5th edition is October 31, 2022. More information can be found at www.aa.org/submit-bigbook-English-5th or you can also email your story to 5bbstory @aa.org.

Implementation has begun on the new jacket-less format for the next printings of the Big Book, Alcoholics Anonymous, in efforts to reduce backorders, streamline turnaround time, and bring the book to the Fellowship in a timely manner. This format will help us better navigate supply-chain disruptions, saving in off-press delivery time as well as expense. The first printing is scheduled to start in mid-October, to be completed November/December 2022.

PUBLIC INFORMATION

The committee approved the revised 2022 Membership Survey questionnaire amended by the survey methodologist according to the 2022 Advisory Action. The committee reviewed and agreed that the project plan to administer the 2022 Membership Survey is comprehensive and will accomplish the goal of producing effective results.

To date I have conducted 3 group surveys and have plans to attend 5 more groups next week. I will be reaching out to DCM's later today to ask for assistance in coordinating the surveys. I appreciate all the support from everyone in Area regarding the surveys!

GSO OFFICE

On March 14, after two years of remote work, another significant step was taken: all GSO and Grapevine employees returned to the office according to their hybrid work schedules.

Additionally, I am excited to share the news that the General Service Office will begin welcoming visitors again beginning Wednesday, October 5. This also includes reinstituting the Friday 11:00 a.m. A.A. meeting. Work is underway in preparing for the 73rd General Service Conference next April 23-29. To date approximately 184 agenda items have been received by the Conference Coordinator. You can review the entire preliminary list here.

I currently serve on the Conference Finance Committee as also serve as Chair of the Conference Archives Committee. In my role as Archives Chair, I will be invited to attend the January Board meeting in New York (all conference committee chairs are invited) so I have begun to prepare for that. Additionally, the Conference Finance Committee has a call scheduled for next week where the Delegates are asked for their input on agenda items relative to their committee assignment. I will report more on that at the Winter Assembly.

• The 14 East Central region Delegates meet monthly to keep abreast of issues happening throughout the region. The call is led by Cathi C. Cathi C who is currently serving on the following Trustees' Committees: Archives, Finance, International Conventions, Forums, Literature, and she is the Trustees GSB Secretary and serves on AAWS Board, Finance, Audit, Nominating, and is our AAWS Treasurer. Our last call was last week, and topics discussed were (ironically) Area funding of Delegates fees (we just passed a motion on that), as well as the possibility of the "Region" covering the seed money expense for the East Central Regional Conference. The latter item will be addressed at the next CDPP and then likely voted on the following year (February 2024).
