### **Grapevine / La Vina**

While App subscriptions across all sources increased dramatically from last year (16,468 vs 13,089 or +26%), decreases in print subscriptions offset those gains resulting in nearly flat performance across all subscriptions (-0.7%).

- Total Grapevine Subscriptions 58,634 vs 59,032, a decline of 0.7% (Print down, digital up)
- Total La Vina Subscriptions 8,360 vs 7,157, 17% greater than prior year
- The La Viña Reforecast for 2025 will have a deficit of \$499,313 to be reimbursed by GSB. This compares to 2024 cost of service of \$571,939.
