#### Conference Reports

##### 2025 State Conference – Jeff L. Conference Chair.

Our Conference was a success thanks to all committees, volunteers, and guest from all around the state. Communication with the hotel was a little difficult . We found out later a new company had bought the hotel so some of what we initially agreed to changed. Financially we broke even; we hit our food and beverage commitment and our room commitment fell three short, but that was questionable as the hotel's systems were down on Friday afternoon into the evening. We had many walk- in registrations that also registered at the hotel that we weren't credited with so we charged for three room's they said we were short \$796.75. On Friday night after the guest speaker we held AA trivia in the same room and where unexpectedly charged \$8,000 dollars for that hour and a half. One other unexpected charge was the extra service

charge of \$120.00 every time the hotel refilled the coffee station. We were initially told that was included in the \$80.00 a gallon charge. We only had coffee service during the main speakers, including Alanon's speaker Saturday afternoon. We purchased only 20 gallons throughout the weekend which helped to make our \$10,000 food and beverage comment. Hospitality, literature, grapevine and decorations all broke even. The ice cream social on Friday night was a little short but that was made up through donations. Our speakers all drove to the event so their reimbursement was minimal.

The GSO member Kelley and the west central trustee were reimbursed for their airfare. We had 370 registrations and sold 15 Banquets in which they ran out of food. All in all, we can return the seed money and any money the Area put in. We spent \$20,000 and took in \$20,000. Our only recommendation is to find another hotel as the HYATT no longer values our long-established history with them.
